CFA (Deadlines July 30, 2021)

In addition to economic development initiatives, eligible project types include:

- wastewater treatment improvement,
- non-agricultural nonpoint source abatement and control,
- land acquisition for source water protection,
- salt storage,
- aquatic habitat connectivity restoration,
- floodplain or wetland restoration to increase climate resilience,
- natural resources inventory (NRI),
- smart growth comprehensive planning,
- local waterfront revitalization program,
- Increasing natural resiliency to the effects of climate change,
- Reducing future flood-risk, including by relocating or retrofitting critical infrastructure,
- Rightsizing culverts and bridges,
- Reducing vehicle miles traveled (VMT),
- Facilitating food scraps recycling at municipal facilities

Description: The Town of Catskill Planning Board is reviewing a Site Plan for T &T Auto Sales to put up to 15 cars at lot at 1136 Route 23 on display for retail sales, operating out of existing office building. The parcel is in the 'Highway Commercial' zone. According to Site Plan Application 'Retail car sales' is a listed permitted use (District-related retail use).

There will be a "small sign" by the road and a sign on the building. Site Plan shows existing sign but does not show new sign. No landscaping —"no trees"

The 239 referral form indicated approximately 12 vehicles would be for sale, the site plan application indicated up to 15 vehicles and the drawing submitted with the referral had what appeared to be 14 spaces; however there was no indication if all of those spaces would be used for vehicles that would be 'for sale' or for customer parking.

Concern was expressed about on-site parking for customers and lack of landscape plantings. It was determined however that these were local planning board issues to address, not county issues.
