
Records Management


The following is a summary of Records Management activity for 2024:

- 183 boxes (cubic feet) of original records were moved from various County Offices into storage at the Records Center and added to the Records Center inventory.
- 515 requests for retrieval of records from storage were processed for County Departments.
- 734 requests for file maintenance were processed (primarily, this involves retrieval of a file to add materials.)
- Approximately 164 boxes of Public Defender records were scanned, verified, and destroyed by Records Center Staff. Another 22 boxes are in various stages of this process.
