Of the two courses held in Greene County, I have had a total of 57 students, both original and refresher. Successful course completion rate is still 94.12% of the 34 original students who completed the original course and were able to sit for course final. Both students that were sponsored by Greene County successfully completed course requirements and successfully tested out. One is currently working in Greene County and the other I have not talked to in a few months but is intending to work in Greene County when her current work contract expires.

- There was one student who withdrew from the first course due to medical care and attended the second course and passed successfully and is now working the mountaintop.
- Nine Students from the first course are actively working in the field or volunteering for their fire departments currently.
- Eleven of the second course are actively working in the field or volunteering for their fire departments currently.
- The two students who failed the course from the second course have already committed to returning for the next course being held in Greene County.

It is important to note that I have successfully completed two courses for Greene County in about 13 months' time that has had a near 95% pass rate (not including the refreshers that have recertified their EMT cards and the dropped students for various reasons). We have successfully incorporated twenty new EMTs into Greene County and the surrounding counties EMS Systems. We have returned eight EMTs back to service and back into continued service directly in Greene County EMS systems.

Our courses consist of roughly 180 hours of classroom instruction over roughly 30 classes and 11 Labs. There was also a 10 patient contact clinical component that each original student completed ranging from 30-60 hours of Clinical Shifts held throughout various agencies in Greene and Columbia Counties.
