#### Mission Statement

Greene County Emergency Services' mission is to provide residents and visitors with 9-1-1 services including receipt of both Emergency and non-emergency calls for assistance and the proper dispatch of appropriate response personnel. This office also ensures, through coordination with county, state, and local shareholders, that the county is prepared to respond to, and recover from, natural and manmade hazards. This office will provide coordination, leadership, and support to reduce the loss of life and property through an all-hazards emergency management program of mitigation, preparedness, response, and recovery throughout Greene County.

#### 911 Communications

#### About

The Greene County 911 Communications Center is the critical link between the public and emergency services across the county—handling every 911 call made from a cell phone, and landlines outside the Village of Catskill. Operating 24/7, the Center is staffed by a dedicated team of full-time, part-time, and per-diem dispatchers. Oversight is provided by the 911 Communications Director, and the Center is located within the Department of Emergency Services.

The Center coordinates emergency communications for 27 Fire Departments, 14 EMS agencies, 9 Police Departments, and three special teams: Greene County Haz-Mat, Greene County Fire Investigation, and the Twin Clove Technical Rescue Team.

In addition to county agencies and services, the 911 Center can also communicate with and provide communication services for city, state and federal agencies including NYS Office of Fire Prevention and Control, NYS EMS, NYS ENCON, NYC DEP, NYS Parole, NYS Park Police. The 911 Center also handles ALL after-hour emergency and non-emergency dispatching for, Greene County Dept. of Social Services, Greene County Mental Health, Greene County Public Health and all Highway Departments.

#### **Key Updates and Initiatives**

In April 2024, the Greene County 911 Center successfully implemented Priority Dispatch Protocols for Fire and Police responses. This marks a significant advancement in ensuring standardized, efficient call handling and dispatching. Additionally, the initial phases of a Quality Assurance/Quality Improvement (QA/QI) program have been launched, laying the groundwork for comprehensive call review and performance improvement across Fire, Police, and EMS calls.

The implementation of Priority Dispatch Protocols for Fire has significantly improved how Greene County 911 handles fire-related emergencies. Prior to this initiative, fire dispatching was often based on general call descriptions and dispatcher interpretation, which could sometimes lead to overgeneralized responses or missed critical details. One of the most impactful outcomes of this change has been the expansion of the call-for-service list, enabling dispatchers to classify and code incidents with greater specificity and giving the fire chiefs greater control over their automatic mutual aid plans.

#### **Team Growth & Development**

We proudly promoted one of our own to Senior Dispatcher, a role that strengthens supervision and leadership on each shift.

Through the NYS HELP (Hiring for Emergency Limited Placement) Program, we welcomed six new full-time hires in 2024. This program temporarily removes the requirement to take the Civil Service Dispatcher Exam, helping agencies like ours fill urgent staffing needs more quickly. Two new hires successfully completed our intensive training program, and another team member hired in December is currently still in training.

By the end of 2024, our team consisted of:

- 15 Full-Time Dispatchers
- 2 Part-Time Dispatchers
- 1 Per-Diem Dispatcher

An increase of two full-time positions compared to 2023.


#### **2025 Goals**

- Recruit and train additional dispatch staff to alleviate the ongoing staffing shortage, with the goal of reaching 18 full-time dispatchers to handle increased call volume and responsibilities.
- Expand the Quality Assurance/Quality Improvement (QA/QI) program into a full-time initiative to continually evaluate and enhance the quality of Fire, Police, and EMS call handling.
- Expand Senior Dispatcher responsibilities to include assisting with CAD/phone system maintenance and updates, as well as involvement in community outreach initiatives.

#### 911 Center Call Volume

There are several numbers that residents of Greene County utilize to contact the 911 Center. Greene 911 has categorized these calls into three categories: 911, Admin, and Admin/Emergency.

- Admin calls are calls that are received on 518-622-3648. An example of this type of call is an employee calling the dispatch center to reach staff or the Director, a vendor contacting 911 Dispatch
- Admin Emergency calls are calls that are received in 518-622-3344. An example of theses
  call types are alarm companies calling to reach the 911 Center, i.e. medical alarm, fire
  and burglar alarm activation. This is also used by other 911 centers or police
  departments/agencies to contact Greene 911.
- 911 calls are calls that are received when someone dials 911 from either a cell phone or a landline phone, with the exception of the Village of Catskill. The Village of Catskill answers only the landline 911 calls that are generated within the Village boundary. If that call is law related, then Catskill Police Department will manage that call. If it is fire or EMS related, Catskill PD transfers that call to the Greene County 911 Center.





## Total Computer Aided Dispatch (CAD) Events 2024









## **Emergency Management**

The Emergency Manager is responsible for overseeing and updating all county emergency management plans, conducts emergency management related training for county staff and other key stakeholders, organizes and conducts exercises, oversees emergency management grants, and serves as the county's interoperability coordinator.

#### **Emergency Radio System**

In 2024 the Fire Response channel was upgraded to a repeated/ simulcast channel to mirror the operations of the Law and EMS channels. This involved adding filtering equipment at all the tower sites and reprogramming the radios at the tower sites and all subscriber equipment. Also in 2024 we ordered equipment for the backup 911 center and the Durham tower site. Durham will become a full site with Police, EMS and Fire channels operating from this location which will improve radio coverage in Durham and Norton Hill areas. The backup center will become a full backup site, capable of operating on its own in the event of a catastrophic failure of the main PSAP; both projects will conclude in 2025.

#### Organizational

In 2024 there were no formal EOC activations, however the Emergency Services Staff supported several incidents through resource coordination and operational support:

- January 9-10 Storm
- March 23-24 Storm
- June 15 Concert in the Catskills
- July 19 CrowdStrike failure/ 911 system interruptions
- August 9-11 Storm
- November 23-24 Storm

This year we continued facilitating the development of a County Animal Response Team (CART) and have a small group of dedicated volunteers actively training to assist the county in times of need. A response trailer was purchased and will be outfitted in 2025.

Engagement with the Greene- Columbia Community Organizations Active in a Disaster (COAD) continued. This group is a vital resource which assists communities following disasters.

The Emergency Manager participated in a Hurricane Evacuation Study conducted by New York State through an outside contractor. This study looked specifically at storm surge events on the Hudson River and identified flood-prone locations relative to expected surge height and tide schedule. These data were utilized to develop evacuation maps and protocols for the river communities.

#### **Community Engagement**

In 2023 we participated in the Greene County Youth fair where we provided many personal preparedness informational pamphlets to residents.





#### **Planning**

Volunteer and Donation Management Plan as well as the Critical Infrastructure and Priority Restoration Plan were completed in 2024 with the help from our planning contractor and key stakeholders. These plans are annexes to the Comprehensive Emergency Management Plan and serve as guide during emergency response and recovery. As each new annex is written, the base plan (CEMP) is also updated to ensure plan symbiosis and reduce the potential for priority conflict when one or more plans are being utilized for a single incident









#### **Exercises**

We conducted two exercises in 2024. The first exercise was a seminar on the Comprehensive Emergency Management Plan (CEMP). This introduced key stakeholders to the plan, its Appendices and Hazard Specific Annexes. Participants were personnel from county departments who have an Emergency Response role in disasters. The second exercise was a tabletop exercise of the same plan. This exercise however challenged participants as they sought solutions to the prepared scenarios utilizing the plan as a guide. We also participated in a full-scale exercise along with Central Hudson and the Coxsackie-Athens School district.

#### Grants

- Public Safety Answering Point PSAP FY23 in the amount of \$143,466.00.
  - This funding will be utilized to support the personnel costs related to the 911 dispatch staff.
    - The entirety of this funding was utilized to support the personnel costs related to the 911 Center. Salaries were reimbursed to Greene County from this funding.
- > State Homeland Security Program (SHSP/SLETPP)
  - This grant program is designed to assist state, local, tribal and territorial efforts in preventing, protecting against, mitigating, responding to and recovering from acts of terrorism and other threats. Funding for this grant is provided by the U.S. Department of Homeland Security, Federal Emergency Management Agency (FEMA).
  - Starting in FY2020, the Department of Emergency Services, as a requirement of this funding, now manages the entire Greene County funding allocation, with a minimum of 30% for the Greene County Sheriff's Office.
  - Projects in this award must include the following: Intelligence and Information Sharing, Enhancing the Protection of Soft Targets/Crowded Places, Combating Domestic Violent Extremism, Community Preparedness and Resilience, Cyber Security and Election Security. To ensure these categories were met, the Department of Emergency Services allocated 36% to the GCSO for the purchase of mobile data terminals, infrared camera technology the continuing subscription of the Sherriff's App.
    - A total of \$95,365.37 from was expended from SHSP/SLETPP FY2021. It was used on the following
      - Multi-stage hazardous materials vacuum for the Greene County Hazmat Team
      - Lithium-Ion storage bags, these were distributed at the Greene County Youth Fair 2024 as well as to multiple County entities/departments
      - Cradlepoints and associated MDT equipment for the Greene County Sheriff's Office
      - First Responder Disability Awareness Training from Niagara University.
    - A total of \$48,883.81 from was expended from SHSP/SLETPP FY2022. It was used on the following
      - Stop the bleed wall mount kits, installed at the Greene County Sheriffs Office, Greene County Jail, and multiple Highway Garages and Solid Waste Facilities.

- One year continuing subscription to the Sheriffs App and the Countys Public Information and Warning program.
- A total of \$92,711.00 from was expended from SHSP/SLETPP FY2023. It was used on the following:
  - Cradlepoints and associated MDT equipment for the Greene County Sheriff's Office
  - Marine Mount Thermal Imaging Camera for the Greene County Sheriff's Office
  - Trailer-mounted mobile generator to be used at various locations within the county. Primarily sourced for use in sheltering operations.
  - One year renewal of lamResponding

#### Statewide Interoperable Communications Grant (SICG)

- This grant will be utilized to continue the build out of an upgraded and enhanced interoperable radio system within Greene County. This will include acquisition of and installation of additional radio equipment, antenna systems, backhaul capabilities, security and site monitoring equipment and associated professional consultants. This grant will also be utilized to offset some of the LMR maintenance costs.
  - A total of \$265,859.71 was expended from SICG FY21. It was used for the following:
    - Purchase and installation of radio equipment in county vehicles.
    - Base station radios and connectivity equipment to expand the capabilities of the Durham Tower Site.
    - RF combining equipment was installed at five of the tower sites to make the fire response channel a repeated channel.
    - Radio consulting costs
  - Grant FY2023 in the amount of \$456,547.00. A total of \$447,919.19 has been encumbered from this grant and is being used for:
    - Radio console control equipment was purchased for the backup
       911 Center

# > Technical Rescue & Urban Search and Rescue Grant Program FY2021- application denied

- This competitive grant focuses on the enhancement of Technical Rescue and USAR teams.
- In FY2018 a Regional Partnership was established with Ulster County for Technical Rescue operations. Equipment was purchased to replace, supplement, or enhance current technical rescue operations.

 Grant funding under the FY2021 Technical Rescue & USAR Grant Program may be used for certain planning, OFPC-approved training, exercises, and equipment costs allowable under the State Homeland Security Program (SHSP)

#### Fire Coordination

#### **About**

The Fire Coordinator is responsible for planning and supervising the County-wide program of fire training and mutual aid to cope with fires and other public emergencies requiring the service of firefighters. The Fire Coordinator acts as liaison officer between the firefighting forces of Greene County, the County Fire Advisory Board, the County Legislature, the County Administrator, and the New York State Office of Fire Prevention and Control. This position involves responsibility over fire control and is in no sense in charge of any fire.

#### **Basic Exterior Firefighting Operations:**

The steady decline of membership in the fire service is a statewide crisis. Greene County would like to develop future generations of firefighters by gaining high school students' interest and involvement in firefighting operations before graduation. With the support of the Greene County Legislature, the Donald R. Kline Technical School (Questar III) in Columbia County began offering Basic Exterior Firefighting Operations to students in high school.

At the start of the 2024 school year, four students from Greene County enrolled in this program. The students learn the basic skills in emergency services and work towards their Basic Emergency Firefighting Operations (BEFO) certifications.

#### **Stipend Program**

In August 2023 New York State Homeland Security and Emergency Services started a new program called *Volunteer Firefighter Stipend Program*. Firefighters must be volunteer firefighters and must be in "good standing" with the authority having jurisdiction. This program has continued into 2024.

Qualifying Courses and Stipend Amounts are:

\$750.00 Upon completing Basic Exterior Firefighting Operations with W/HMFRO \$1250.00 Upon completing SCBA/Interior Firefighting Operations. \$1000.00 Upon completing Fire Officer I. \$2,000.00 Upon completing BEFO-SCBA/IFO

#### **Fire Training Center Repairs**

The fire training center has received minimal repairs since its construction in 2008. In 2024 WHP Tower performed a thorough inspection of the facility. The inspection report identified 27 distinct deficiencies which could pose a safety hazard to the firefighters. It was determined to be in in need of approximately \$75,000.00 in repairs. A purchase order was issued to WHP. This work is due to be completed in the first quarter of 2025. At that time, the operational limitations will have been fully refitted and the center wholly operative.

### **Bullex Propane Car Prop:**

In June of 2023 the Greene County Legislature authorized the purchase of a vehicle training prop for live fire training. The Bullex Propane Car Prop was operation in Summer 2024. A demonstration was provided during Interior Firefighing Operations Course. We invited all departments and companies in the county to be present for the demonstration.





#### **Multi-Force Forcible Entry Door System:**

The department acquired a multi-force forcible entry door system to be used at the fire training center.

This door system is a realistic and versatile forcible-entry training device. Departments across the county can schedule time at the training center to train their members using every technique applicable to inward-opening doors, outward-opening doors, left-hand and right-hand swinging doors with metal or wood jambs, using a Halligan and flat-head axe or maul. Hydra Ram and rabbit tools can also be used.




## **Greene County 2024 Fire Training Report:**

We had two (2) fire training meetings with the NYS Office of Fire Prevention and Control and the NYS Fire Instructors assigned to Greene County to schedule fire training courses for 2024. The first meeting was on May 15, 2024, and the second was September 18, 2024.

We scheduled twenty-one (21) courses. We completed fourteen (14) courses, but we had to cancel seven (7) of twenty-one (21) due to lack of enrollment.

#### **GREENE COUNTY HAZMAT TEAM:**

#### **About:**

The Greene County Hazmat Team is a regional hazardous materials response team. They participate in regional training events and respond to emergency calls with neighboring Columbia County. The Regional Hazmat Team's purpose is to handle hazardous materials (HazMat) incidents safely and efficiently. This is accomplished by enhancing the implementation of the Emergency Planning and Community Right-to-Know Act of 1986 (EPCRA), and encouraging a comprehensive approach to emergency training and planning by incorporating the unique challenges of responses to transportation emergency incidents.

In the Spring of 2024 the department hired one (1) part time fire deputy specifically assigned to oversee the hazmat team. The Hazardous Materials Deputy Coordinator was hired in May 2024. This individual oversees the team, equipment calibration, scene safety, and acts as a liaison to the Director of Emergency Services.

The team is comprised of trained volunteer firefighters and officers from Fire Departments across Greene County. The team consists of personnel with various levels of chemical, biological, radiological, nuclear, and explosive (CBRNE) training. Positions include Hazardous Materials Technician, Hazmat Decontamination Tech, Hazmat First Responder Operation, and Scene Support operations personnel.



#### 2024 Activities:

The Greene County HazMat team conducted two Hazardous Materials Emergency Preparedness (HMEP) grant funded training exercises for transportation emergencies. This was a joint regional exercise of the Greene-Columbia Regional HazMat Team. The training was conducted in the Fall of 2024 at the Columbia County Training center.

In the fall of 2024 Emergency Services acquired a grounding and bonding kit. Not only can this be used for testing grounding at any of the county's communication tower sites, but it can also be readily deployed to the hazmat team to prevent any static discharge ignition points.







#### Summer/Fall Training 2024:

- The Greene County Hazmat team participated with Columbia County Hazmat as a regional team for a hands-on exercise at the Chatham High School complex. This was a NYSDEC Geographic Response Plans (GRP) training event. Greene County participated by responding with its NYSDEC Spill trailer.
- The Greene county Hazmat team conducted a walkthrough at Ducommun Aerostructure facility located in Coxsackie, NY.
- The Greene and Columbia County Regional Hazmat team performed a joint pressure testing drill to inspect and test all Level "A" suits for Greene & Columbia Counties.
- Greene County Hazmat team, along with Columbia and NYSDEC provided a classroom and hands-on exercise for the mountain-top fire departments. We deployed our harbor booming and underflow dam systems in the Batavia Kill Creek at the Ashland Town Park.
- Members of the team attended the NYS Hazardous Materials Leadership Forum. This program was hosted by NYS-OFPC.
  - Topics included updates from the NYS Fire Hazmat Office; Grants provided a presentation, Unmanned Aircraft Systems (UAS) for Hazmat and NYS threat assessment updates.

All the necessary calibration and bump tests on all the HazMat Team detectors are performed and completed monthly. The calibration and bump test takes approximately three (3 to 4) hours to complete.

**PUBLIC RELATIONS:** The Greene County Hazmat Team attends various public events throughout the year. We annually participate in the Greene County Youth Fair in Cairo. New in 2024, we set up our Hazmat "COOL ZONE" as visitors came to get a cool mist during the hot day. We also participate in various parades throughout the county.

#### 2024 Hazmat Incidents.

The Greene County Hazmat Team responded to 6 emergency incidents in 2024 as noted below.

- 5 incidents in Greene County.
  - Sept 2024, CATSKILL NYS Thruway, Tractor trailer rollover
  - Sept 2024, CATSKILL, Freon leak
  - December 2024, COXSACKIE, Unknown substance
  - December 2024, Greeneville, Structure Fire
  - December 2024, Coxsackie, Acid leak
- 1 in Columbia County.
  - December 2024, Fuel Spill

#### **EMS Coordination**

#### About:

The EMS coordinator acts as a liaison between the EMS providers and County Officials. The EMS Coordinator responds to emergencies, represents EMS at community and departmental meetings, acts as the NYS DOH liaison for EMS services in Greene County, and maintains knowledge of all local, state and federal laws regarding the regulation of emergency medical services. We strive to ensure all EMS agencies have a full understanding of emergency plans and procedures.

#### **2024 Summary of Activities:**

In 2024, EMS agencies in Greene County continued to face some staffing shortages. In 2023, the Greene County Legislature recognized the need to assist residents who wished to become and EMT but had not taken the course due to cost. With the help of the Legislature students that faced financial hardships were able to take the EMT course, at no cost to them, with the stipulation that they actively serve as an EMT in Greene County for 18 months. This program continues and is offered at the beginning of every new EMT course.

Local hospitals continued to struggle to maintain staffing levels. The EMS Coordinator, along with EMS Administration in the County continued to advocate for decreased wait times and possible solutions. The EMS Coordinators have also continued to work with Hospital Administrative staff in the attempt to improve critical communications between hospital staff and the 911 Center. The implementation of APP-based communication and earlier notifications to the Emergency Departments has helped reduce these wait times, but they continue to have issues in certain high-volume times.

The EMS Coordinator and deputy worked with the 911 center to implement an updated System Status Movement plan for the dispatchers to follow. We made modifications and monitored reality-based locations for the staging of EMS units when call volumes increased and available units were depleted. A new policy and procedure was developed and the 911 Center staff was trained by the EMS Coordinator. This plan ensures the quickest response times to medical calls when local agencies are unavailable due to prior calls.

In the Fall of 2024, the Greene County Legislature entered into a contract with a consulting firm to perform an objective review. In 2025 the Greene County Legislature, Administration from EMS agencies throughout the county, County Administration will discuss the potential for different system designs/development. The company will also perform a detailed operational and financial review.

# **Closing Remarks**

Greene County Emergency Services reaffirms our commitment to building a resilient and prepared community. The challenges we face in emergency services are complex and ever evolving, requiring us to adapt and strengthen our capabilities continuously. We thank our dedicated staff, partners, volunteers, and other stakeholders for their unwavering commitment to ensuring the safety and well-being of our residents. Let us continue to work together, fostering a culture of preparedness and collaboration, so that we can effectively respond to any event and emerge stronger, more resilient, and better prepared for the future.
