

## What does “PINS” mean?

A child under the age of 18 who does not attend school, behaves in a way that is dangerous or out of control, and/or often disobeys his or her parents, guardians or other authorities, may be found to be a Person In Need of Supervision or "PINS".

When community-based services and support have been exhausted and behaviors continue to escalate, a PINS petition may be filed in Family Court. A PINS petition is filed as an action of last resort, when all voluntary efforts have failed and/or the safety of child or others is in question. Once a petition is filed in court, involvement is no longer voluntary - all decisions are then made by Family Court.

The Greene County Youth Bureau Supportive Youth and Family Pre-PINS program is the first step in mentoring youth who are at risk of a PINS petition.

## What is the Youth Bureau Supportive Youth and Family Pre-PINS Program?

The primary objective of the Youth Bureau Pre-PINS Supportive Youth Program is a voluntary point of entry program to support services for youth and their families when incorrigible behaviors and/or school avoidance/truancy may lead to further involvement in Family Court, Juvenile Justice System, or Probation. The Youth Bureau Pre-PINS Supportive Youth Program is designed to support and mentor youth and their families in the county.

### Eligibility

- Youth must be ages 12-18
- Youth must reside in Greene County
- Youth must not already be on Probation, have a history of PINS, or have previous unsuccessful history in the Youth Bureau Supportive Pre-PINS program
- Youth and family have no current open case with Greene County Department of Social Services (Preventative, CPS, IAPP or other caseworker services)

## **To Make a Referral**

Services are initiated by a referral from Parents/Guardians, School Districts or Law Enforcement..

Once a referral is accepted, a Youth Bureau staff member will schedule a meeting with the parent and/or guardian, youth and referral source. Youth Bureau staff will work with the parties involved to assess the situation, provide support and make referrals to partner agencies as warranted.

## **Roles and Responsibilities**

Parents/Guardians are part of the effort to identify their child's needs. Parents and/or Guardians are expected to work with the Youth Bureau staff and their child to secure the necessary preventative services and behavioral changes needed for a successful outcome.
