THE YEAR IN REVIEW

Greene County Council on the Arts entered its 43rd year of service supporting and advancing the arts at the county, state and federal levels. 2018 was a year of transitions and growth! GCCA made a bold decision to regionalize its efforts, based on strong suggestions from the New York State Council on the Arts, and the potential need for services in those communities where Arts Council failed over the last years. GCCA has expanded its role as an arts leader providing significant programs and services to the community, arts organizations, schools and individual artists. Through our various programs, GCCA remains strong in its arts advocacy work, service to the arts and taking significant strides in public engagement. We envision a community that celebrates artistic and cultural diversity and inspires creative engagement.

The impact we have made in 2018 is astounding! Through our programs and services, GCCA has regionalized its efforts serving Greene, Columbia and Schoharie counties reaching over 40,000 individuals, as follows:

- Administered and distributed 65 regional grants totaling \$150,280 to support the work of artists, arts organizations and the cultural community
- Amassed a membership of over 545 individuals, families, businesses and civic groups
- Provided creative arts workshops and exhibitions to over 650 children and youth
- Curated and organized 9 visual arts exhibitions highlighting local and regional artists
- Participated and promoted various events and festivals
- Published 6 Arts Alive, bi-monthly arts and cultural newspaper.

July 9, 2018.

Thanks to the continued support of State funding from New York State Council on the Arts for General Operating support, to which we received a slight increase and for the Decentralization Community Arts Grants Program which enables us to fund programs at a higher level than in previous years. We are also grateful to the Greene County Legislature for recognizing the value of the work we do in Greene County through the funding of nearly \$60,000 to support our general operating, regranting capabilities to major county cultural organizations (CIP), and Sprouts - our free summer art workshops for youth, ages 3-7.

ART EDUCATION - SPROUTS & Outside the Lines

SPROUTS concluded another season of summertime fun for Greene County youngsters in creative arts workshops. This program brought weeklong workshops in Art, Music, Theater and Dance taught by professional artists, free of charge, to Greene County children, ages 3-7, in various locations including Windham, Coxsackie, Cairo, Greenville, Hunter and Catskill during July and August. GCCA's SPROUTS program serves about 60 children per week culminating in serving over 360 young dancers, thespians, musicians and artists throughout the summer. An annual Outside the Lines Youth Arts Exhibition

showcases the works of over 300 children, PreK-12, from private, public and home schools. Field Trips to the gallery form a large part of our arts education curriculum design to education students on the history and heritage of our County and to learn directly from artists about the artistic process. GCCA's Arts Education Partnership fosters invaluable classroom experiences in Greene, Columbia and Schoharie County schools and its Cultural Funds promote and foster the robust cultural and economic environment in the region.




TECHNICAL ASSISTANCE PROGRAM

Fourteen (14) DEC Seminars workshops were held in 3 counties to provide information and assistance on the NYSCA Decentralization grant application process. GCCA also hosted a series of technical assistance seminars that provided workshops on a variety of topics including developing community partnership, broad recruitment and nonprofit; media and community outreach among other subjects. The 2018 series will continue through June 2019.

EXHIBITIONS

GCCA presented nine exhibitions in 2018 highlighting local and regional artists:





• January 27 – March 10, 2018 - "Ginnie Gardiner & Martin Katzoff: Conversations in Color"

GCCA's 2018 season began with the pairing of the two artists, whose works were exhibited during the Patricia Field Art fashion event in October 2017. Production designer Geoff Howell noticed "a conversation" between the two artists' works and a new exhibition emerged.

- March 17 April 21, 2018 "Outside the Lines"
 Youth Exhibition featuring artwork by pre-K through Grade 12 students from Greene County public, private and home schools.
- April 28 June 9, 2018 "Resident Alien"
 Immigration themed exhibition featuring foreign born artists
 living in the Hudson Valley showcased a collection of works

ranging from painting, sculpture, prints, poetry, and installation that collectively provided fascinating insight into how artists integrate their past with their present.

• April 28 – June 9, 2018 - "The Bower Bir-d," a long-anticipated retrospective of the late great assemblage artist Norman Hasselriis (1918-2006) included dozens of Norman's whimsical exuberant "outsider" works as well as prints, photographs, and a 30-minute documentary about his process which ran concurrently with the group show Resident Alien.



June 16 – August 4, 2018 - "New School,"
 a group exhibition of local artists who create artwork inspired by the Hudson River School that Thomas Cole founded in honor of the 200th anniversary of Cole's first Atlantic crossing.

- a solo exhibition of multidisciplinary artist, Caitlin
 Parker, whose work involves printing on paper and
 fabric with pressed plants and experimentation with
 natural dyes, cyanotype process on fabric, sewing and

 featuring emerging artists Louise Smith, Marty Katzoff, Becca Van K, Elbert Perez, Simeon

 Walls and David Aron for the Bright Future Group Show, a sign of hope not subscribing to any
 politics.
- November 17 January 12, 2019 "Salon 2018"

GCCA's much anticipated annual Winter Salon and Handmade Holidays exhibition featuring original artwork from our Artist Members! One of a kind hand built crafts, from pottery to designer sunglasses, were featured in the upstairs Artful Hand Gallery boutique laden with

locally made crafts: ceramics, wearable art, jewelry, toys and holiday cards made by GCCA member artists as well as books, CDs and films by area authors and musicians. Over 100 artist members participate and over 350 works displayed.



COMMUNITY OUTREACH

GCCA participated in events and festivals through the year offering information on its various programs and services. GCCA was instrumental in the promotion for The Corning Museum Glass Barge in June, Hudson Black Art and Culture Festival, Catskill Street Festival, Historic Bridges of NY Skywalk Festival in September with 13 Artists members participating and the Hudson Valley Dance Festival in October. The Visual Arts Student Gallery Visit Program included two guided tours and artmaking sessions to Catskill High School Art Club. Through our bi-monthly newspaper, Arts Alive, our website(www.greenearts.org), and our weekly Constant Contact e-blasts, all of these activities and more cultural arts programming are promoted. Arts Alive reaches households and readers in excess of 20,000.

FUNDRAISERS



GCCA's major fundraiser, **Beaux Arts Ball**, took place on April 7, 2018 at Hunter Mountain with over 160 in attendance, grossing \$59,960. The success of the Ball is directly linked to the generosity of our benefactors and artists, whose donations of art for the auction build substantial proceeds. Special acknowledgements to Nina Matis and Alan Gosule and the Bank of Greene County for underwriting this event. The 2018 Distinguished Service Award went to Todd Whitley, one of the founders of the Hudson Valley Dance Festival, lecturer at Columbia

University and Board member of the Friends of Beattie-Powers and marketing consultant to GCCA. Seventy-one (71) businesses and 73 GCCA Artist members donated 144 separate items to the silent auction. Play GOLF & Swing for the Arts Fundraiser took place on August 24, 2018 at the Catskill Golf Club located at 27 Brooks Lane, Catskill, NY. Led by Board President, Bill Deane, this fundraiser received underwriting and sponsorship support from Event Benefactor Columbia Greene Federal Credit Union, Lunch Sponsors Columbia Memorial Health and Lee E. McGunnigle, Tee Sponsors Jeff & Laura Burnham, Kathoderay Media, R.C. Lacy Inc., Millspaugh Camerato Funeral Home, Sawyer Chevrolet, Shook Porto Insurance Agency, The Wine Cellar, Villa Vosilla, Windham Chamber of Commerce and Windham Fine Arts. GCCA grossed \$5,000. Five (5) businesses and eighteen (18) GCCA Artist members donated their original artwork for a special auction.

CHANGES TO BY-LAWS

Proposed amendment to the By-Laws last amended 1/27/2018. This amendment was approved by the GCCA Board at its December 6, 2018 meeting.

The purpose of the amendment is to establish term limits for Board members and memorialize our current practice of appointing new Directors mid-year. This was identified in our current Strategic Plan as an important revision to our By-Laws:

ARTICLE VII: ELECTIONS AND RETURNS OF DIRECTOR OF THE BOARD

- 1. The election of the Board of Directors will take place at the Annual Meeting.
- **2.** Directors shall be elected to serve three year terms. The term of office for a Board member shall be three (3) years unless otherwise provided in these By-Laws. The terms of office for all Directors shall begin on the day of their election by the member.
 - A director shall be eligible to serve two consecutive three (3) year terms subject to the requirements as stipulated herein. After a period of one(1) year after the end of the Director's second term the Director shall be eligible to serve an additional three (3) year term. For the purpose of establishing status of current Directors they are assumed to be new Directors if they were appointed after 1/2018; they will be considered to be beginning their second term if they were appointed between 1/2007 and 1/2015; and they will be considered to be in their third term if they were appointed prior to 1/2007.
- 3. In the event of the resignation, rem oval, illness, death or lapse of membership of a Director, the Board of Directors may appoint someone to fill out such a term. The Board shall have the right to appoint new Board members during the current year subject to the Membership approving the appointment at the next annual meeting. At the next annual meeting following the vacancy, the Membership shall elect
